EXECUTIVE SUMMARY



SEAS was established in 1968 as a regional research institute to promote scholarship, research, analysis, and dialogue on the region's multi-faceted issues, challenges and problems of stability and security, economic development, and political, social, and cultural changes. To this end, the Institute's multi-disciplinary activities encompass research and publications; public lectures, conferences, seminars, and workshops; and training and briefings.

The core geographical focus of the Institute is Southeast Asia and ASEAN. Within Southeast Asia, the country focus has shifted increasingly away from continental Southeast Asia to Indonesia and Malaysia. ISEAS also functions as Singapore's APEC Study Centre and as such, its activities encompass the APEC region. Since 1998, ISEAS has also been the regional co-ordinator of the East Asian Development Network (EADN), a World Bank–funded regional research network that encompasses over thirty research institutes in the region stretching from China in the north to Indonesia in the south. This co-ordination role clearly establishes ISEAS as a hub institute in East Asia.

Highlights of the year's activities are given below:

- (1) Major research projects, either ongoing or newly launched: Economic recovery and restructuring in East Asia; trade, investment, and financial co-operation and integration in East Asia; regional trading arrangements in East Asia; governance and sustainable development in East Asia; challenges of globalization for Southeast Asia; developments in ASEAN economic integration; foreign direct and portfolio investments in Southeast Asia; financing sustainable development in Southeast Asia; rethinking the development model in Southeast Asia; ASEAN-China economic relations and FTA; ICT development in Southeast Asia; government, politics, and security in Southeast Asia; nation-building in Southeast Asia; civil society in Southeast Asia; media development in Southeast Asia; Islam in Southeast Asia; developments in Indonesia, East Timor, Malaysia, Vietnam; China-Taiwan relations; China-ASEAN relations.
- (2) Major public lectures: Public Lecture by Prime Minister Thaksin Shinawatra of Thailand on "Rethinking Recovery" in August 2001 and the twentieth Singapore Lecture by Prime Minister Junichiro

- Koizumi of Japan on "Japan and ASEAN in East Asia: A Sincere and Open Partnership" in January 2002.
- (3) Major conferences and seminars: The annual Regional Outlook Forum 2002 in January, which brought together international, regional, and local expertise to examine the emerging economic and financial outlook for the region and individual economies and attended by over 400 paying participants; East Asian Development Network Third Annual Forum; ASEAN Roundtable 2001; Forum on Regional Strategic and Political Developments. Under the Trends in Southeast Asia series, several seminars on political, security, and economic developments in Indonesia, Malaysia, and Thailand and on Islam were organized.
- (4) Numerous briefings on Singapore, Southeast Asia, ASEAN, East Asia, and APEC were given by the Director and research staff. Those briefed included: visiting foreign dignitaries, scholars, and researchers; heads and senior staff of foreign universities, research institutes, regional and international organizations; staff and postgraduate students from foreign universities on study trips; the foreign diplomatic corp in Singapore; Lee Kuan Yew Exchange Fellows; and Singapore diplomats proceeding on overseas postings.
- (5) ISEAS continued to host some one hundred visiting scholars and researchers a year. They came from all over the world, with the majority from Southeast Asia. They stayed for periods ranging from a week (primarily to use the facilities of the ISEAS Library) to over a year, and were either self-funded, funded from ISEAS internal resources, or funded by grants and fellowships administered by ISEAS.
- (6) Extensive networking continued to be maintained with universities, research institutes, think-tanks, and individual scholars and researchers in Southeast Asia, East Asia and beyond, and with regional and international organizations. As an APEC Study Centre, ISEAS was linked to other APEC Study Centres and participated in the annual meeting of the International Consortium of APEC Study Centres. As regional co-ordinator of the World Bank-funded East Asian Development Network (EADN), ISEAS was instrumental in developing the grouping and it also networked with over thirty member research institutes in the East Asian countries.

The ISEAS Library continued to be an invaluable resource for both resident and visiting scholars and researchers, as well as for the Singapore public and private sectors. The library collection of Southeast Asian materials is one of the best in the world.

The ISEAS Publications Unit continued to gain in regional and international reputation as a publisher of scholarly and contemporary works on Southeast Asia and East Asia. During the year, the Unit was responsible for some thirty-one publications, including the three journals, ASEAN Economic Bulletin, Contemporary Southeast Asia, and SOJOURN: Journal of Social Issues in Southeast Asia; and the two annuals, Southeast Asian Affairs 2001 and Regional Outlook: Southeast Asia 2002–2003. In addition, ISEAS issued numerous Working Papers and Trends in Southeast Asia papers. The Institute's research papers and publications are listed on the ISEAS website < http://www.iseas.edu.sg > .



ISEAS is dedicated to long-term reflective analysis and investigations in the best traditions of scholarship. The Institute also seeks to stimulate thinking on and exploring solutions to some of the major salient issues in the region.

To achieve these aims, the Institute conducts a range of research programmes; holds conferences, workshops, lectures, and seminars; publishes research journals and books; and generally provides a range of research support facilities, including a large library collection.

RESEARCH PROGRAMMES AND ACTIVITIES

he research programmes and activities at ISEAS are carried out by a core group of research staff as well as by a larger group of visiting scholars, researchers, and affiliates. The research and related activities of the Institute are grouped under three research programmes — Regional Economic Studies (RES), Regional Strategic and Political Studies (RSPS), and Regional Social and Cultural Studies (RSCS).

Research Staff

The Director of Research, Professor Chia Siow Yue, oversaw more than twenty senior fellows, fellows, senior research fellows, research associates, and research assistants during the year, each assigned to one of the three research programmes. The research staff are engaged in numerous activities besides group and individual research. They function as co-ordinators and organizers of research projects, training programmes, conferences, public lectures, and seminars; editors and referees of ISEAS journals, working papers, and book publications; resource persons for training programmes and briefings; as well as oversee the visiting researchers and scholars.

Appendix IV lists the research and publications of the Director and research staff for the year.

Visiting Researchers and Affiliates

ISEAS played host to forty-five researchers and scholars in FY2001/02. The lists of visiting researchers, scholars, and affiliates are given in Appendices V and VI. They fall into the following categories:

- Visiting research fellowships on ISEAS stipend or ISEAS-administered grants. These vary in seniority and duration and include the Distinguished Professorial Research Fellow, Visiting Professorial Fellow, Visiting Senior Research Fellows, Visiting Senior Fellows, and Visiting Research Fellows.
 - Since 1994, ISEAS has been administering the Tun Dato Sir Cheng Lock Tan M.A. Scholarship Programme, funded from the Tun Dato Sir Cheng Lock Tan Trust Fund. The Scholarship scheme is intended to provide deserving young Singaporeans with the opportunity

Research Staff, Visiting Researchers, and Affiliates by Discipline, 2001–02




- to pursue postgraduate studies locally and overseas in the areas of politics, international relations, economics, and sociology.
- Since 1996, the Singapore International Foundation has been funding the Singapore International Foundation Research Fellowships on Southeast Asia. These short-term fellowships are offered to promising Southeast Asians, particularly Indonesians.
- As the regional co-ordinator of the World Bank-funded East Asian Development Network, ISEAS has served as host institution for the East Asian Development Network Fellowships for Young Economists.
- Visiting researchers and scholars not on ISEAS stipend or ISEAS administered grants. They are either self-funded or funded by various foundations and grants. The Institute offers them a range of research facilities, ranging from office space to library facilities.
- Associate fellowships, without remuneration, are offered to some academic staff from the National University of Singapore and Nanyang Technological University. Such affiliation enables these academics to participate in ISEAS research and training projects and to use the Institute as the base for their sabbaticals.

Regional Economic Studies (RES) Programme

(Co-ordinator: Professor Chia Siow Yue)
(Deputy Co-ordinator: Dr Nick Freeman)

The RES programme focuses on the economic issues of Southeast Asia, ASEAN, and East Asia, and incorporates the activities of the APEC Study Centre. Research projects and activities during the year included: ASEAN's development and challenges in the new millennium; free-trade arrangements and AFTA in Southeast Asia; ASEAN growth triangles; economic reforms and business liberalization in ASEAN transitional economies; foreign direct and portfolio investments in Southeast Asia; foreign investment legal regimes in Southeast Asia; globalization challenges for Southeast Asia; information technology developments and challenges in Southeast Asia; environmental issues in Southeast Asia; ongoing financial, banking, and corporate restructuring in Southeast Asia; exploring new financing methods for sustained economic development; East Asian economic recovery and restructuring;

regional trading arrangements in East Asia; financial co-operation and integration in East Asia; human security issues in East Asia; China's WTO accession implications for Southeast Asia; ASEAN-China economic relations; and central banking in Indonesia.

Major activities for the year included the ASEAN Roundtable on "Financing Sustained Economic Development in Southeast Asia" held on 22–23 October 2001. The papers presented at the Roundtable included detailed examinations of various financing methods available, and the extent to which they could be better harnessed in the future, as part of a more diverse spectrum of funding sources for the region's long-term economic development. Participants from eight Southeast Asian countries attended, along with experts from beyond the region and the major multilateral lending agencies.

Major Research Projects

Research staff were actively engaged in individual research. In addition, they co-ordinated and participated in the following group research projects:

- Project on "Rethinking the East Asian Development Model in Southeast Asia", which is to be published as a special focus issue of *ASEAN Economic Bulletin*, edited by Dr Nick J. Freeman and Dr Denis Hew.
- Book project on "The Future of Foreign Investment in Southeast Asia", co-ordinated by Dr Nick J. Freeman, due for completion in late 2002.
- "Regionalization, Foreign Direct Investment, and Poverty Reduction", funded by the Department for International Development (DfID) of the United Kingdom. Dr Nick J. Freeman and Dr Mya Than are participants in this project. This is part of a large umbrella project being funded by the DfID, examining various issues pertaining to globalization and poverty.

Major Conferences and Workshops



- Third Regional Experts' Conference on Food and Agriculture Policy, "Implications of the ASEAN Free Trade Agreement (AFTA) on the Sustainability of the Agriculture Sector on Southeast Asia".
- Asia Development Research Forum: "Shaping Asia's Voice: Challenges of Economic Integration and Challenges of Ageing". The forum focused on three areas: Economic and Financial Governance; Ageing Asian Populations; and Asian Conflict Resolution.
- APEC Roundtable and APIAN Workshop: "APEC at the Dawn of the 21st Century". Nine papers were presented on pertinent topics at the Roundtable.



Regional Strategic and Political Studies (RSPS) Programme

(Co-ordinator: Dr Derek da Cunha)

The RSPS programme addresses strategic issues within the Southeast Asian setting and the dynamics of political change in the regional states. It deals not only with regional responses to globalization trends and universal concepts but also with empirical and theoretical issues related to politics, security, and international relations from the regional and national perspectives. The programme is also aimed at enhancing the knowledge and understanding of the region by Southeast Asians themselves; expanding the existing body of regional expertise on strategic and political matters; and constructive exchanges of views and ideas among those in the region as well as between the region and the rest of the international community.



The year saw the materialization of the results of two projects with the publication of the edited volumes *Government and Politics in Southeast Asia*, and *Singapore in the New Millennium: Challenges Facing the City-State*. Both projects had been in the pipeline for some time.

The year also saw the launch of a highly successful series of major RSPS seminars, each comprising a panel of speakers. The rationale for this series was the fast pace with which events had been changing regionally and internationally and the need to debate some issues of concern at short notice. Experts were flown in specially to make up the panel of speakers for each of these seminars. Details of the seminars are listed below.

Major Research Projects

- Book project on Government and Politics in Southeast Asia, edited by Dr John Funston. This volume takes a comprehensive look at the practice of government and the conduct of politics in the ten Southeast Asian states. The volume has now become a standard reference work on the domestic politics of states in Southeast Asia.
- Book project on Singapore in the New Millennium: Challenges Facing the City-State, edited by Dr Derek da Cunha. This volume examines the multi-faceted economic, social, and political challenges which Singapore will face in the years ahead from both within and without.
- Book project on "Governance in Indonesia: Challenges Facing the Megawati Presidency", edited by Dr Hadi Soesastro, Dr Anthony L. Smith, and Ms Han Mui Ling. Publication is forthcoming later in 2002.

Major Forums and Seminars

 Fifth annual forum on "Regional Strategic and Political Developments", held on 25 July 2001. RSPS researchers and two keynote speakers, former Malaysian Deputy Prime Minister Musa Hitam and former

The Forum attracted 400 paying participants.

- Public seminar on "Regional Political and Strategic Implications of the Terror Attacks in the United States", held on 9 October 2001.
 It drew a record audience of 216 for an ISEAS seminar. The seminar featured a panel of four speakers, including two RSPS researchers.
- Public seminar on "Islam in Southeast Asia: Analysing Recent Developments", held on 15 November 2001. The seminar featured four speakers, including three who were specially flown in. Some 200 people attended the seminar.
- Public seminar on "Assessing Democratic Evolution in Southeast Asia", held on 6 February 2002. For this seminar, a panel discussed the evolution of democracy in Indonesia, Malaysia, the Philippines, and Thailand.

Contemporary Southeast Asia is the Institute's journal on international and strategic affairs. A total of three issues are published each year.



Regional Social and Cultural Studies (RSCS) Programme (Co-ordinator: Dr Lee Hock Guan)

The Regional Social and Cultural Studies (RSCS) Programme at ISEAS is devoted to the study of key issues in the socio-cultural development of Southeast Asia, including globalization, urbanization, migration, social class formation, nation-building, ethnicity, religion, family, and gender.

Major Research Project

"History of Nation-Building in Southeast Asia", co-ordinated by Professor Wang Gungwu. This project looks at the processes of nationalism, nation-building, and regionalism in Southeast Asia in the last four decades through a historical perspective. It covers the selected cases of Thailand, the Philippines, Indonesia, Malaysia, and Singapore, which will be examined by five prominent historians of the respective countries. The project aims to produce a series on the nation-building histories of the five countries and a sixth volume that takes a regional view.

Major Conferences and Workshops

- Workshop on "Civil Society in Southeast Asia". The project examines three aspects of civil society in Southeast Asia: (1) the character and roles of civil society, (2) the strengths and weaknesses of groups in performing their various roles, and (3) the multi-layered relations between state and civil society. A workshop was held on 12-13 November 2001 where one overview paper and thirteen country discussion papers were presented by researchers from the region. Dr Lee Hock Guan, the projector co-ordinator, is preparing selected papers from the workshop for publication as a book by ISEAS.
- Vietnam Update Project. In conjunction with the Australian National University (ANU), ISEAS hosted the Vietnam Update 2001 Conference on 19–20 November in Singapore. The Update is a series of annual conferences that look in detail at specific themes related to Vietnam. Since it was launched at the ANU in 1990, the Update has covered topics such as the law, education, mass media, and civil society. The theme for the 2001 conference was "Governance in Vietnam: The Role of Organizations". Dr Russell Heng and Dr David Koh are the project co-ordinators.



SOJOURN: Journal of Social Issues in Southeast Asia is the Institute's journal on society and culture. Two issues are published each year.

Trends in Southeast Asia (Co-ordinator: Dr Anthony L. Smith)

In view of the dramatic developments in Southeast Asian countries following on the outbreak of the Asian financial crisis in July 1997, ISEAS launched this public seminar series to contribute to a better understanding and appreciation of important contemporary developments in the region among the policy-making, research, and business communities.

The seminar organized on 4 May 2001 was "Trends in Indonesia: Visions for Indonesia's Future". The speakers were Mr Ade Komarudin, Member of Parliament, GOLKAR Party; Mr Ali Masykur Musa, MA, Member of Parliament, National Awakening Party, or *Partai Kebangkitan Bangsa* (PKB); Mr Alvin Lie, Member of Parliament, National Mandate Party, or *Partai Amanat Nasional* (PAN); Dr Irwan Prayitno, Member of Parliament, Justice Party, or *Partai Keadilan* (PK); and Mr Parmono Anung, Member of Parliament, Indonesian Party of Democracy-Struggle, or *Partai Demokrasi Indonesia-Perjuangan* (PDI-P).

Regional Networks

(Co-ordinator: Professor Chia Siow Yue)

ISEAS continues to network extensively with academic institutions, individual scholars and researchers, and regional and multilateral institutions and groupings not only in Southeast Asia but also in Northeast Asia, South Asia, Indian Ocean Rim, Western Europe, North America, and Latin America. Networking takes many forms — ISEAS membership of formal networks; foreign participation in ISEAS conferences, workshops, seminars, and publications; joint organization of conferences and seminars either in Singapore or overseas; ISEAS Director and research staff participating in joint research projects and in overseas conferences and workshops.

Five major networks are described below:

 Singapore APEC Study Centre: The Institute has been operating as Singapore's APEC Study Centre (ASC) since 1994 and is a founder member of the International Consortium of APEC Study Centres. Professor Chia Siow Yue, in her capacity as Director of the Singapore ASC, has been participating actively in the annual meetings of the International Consortium of APEC Study Centres, which represents the academic arm of APEC. The 2001 meeting was held in Tianjin (China) and the 2002 meeting is scheduled for Merida (Mexico). ISEAS organized the APEC Roundtable on "APEC at the Dawn of the 21st Century" in June 2001 and hosted the meeting of the APEC International Assessment Network (APIAN), a subgroup of the APEC Study Centres, and published APIAN's research monograph on Assessing APEC's Progress: Trade, Ecotech and Institutions.

- Pacific Economic Cooperation Council (PECC): Professor Chia Siow Yue is a council member of the Singapore chapter of the PECC (SINCPEC). She represented SINCPEC at the meetings of two PECC task forces, namely, the Trade Policy Forum and the Financial Restructuring Task Force. Professor Chia participated in the Trade Policy Forum on Regional Trading Arrangements in Bangkok in June 2001; the PAFTAD meeting in Canberra in August 2001; and the PECC XIV Meeting and International Forum on Financial Cooperation and Regionalism in East Asia in Hong Kong in September 2001.
- East Asian Development Network (EADN): In mid-1998 the World Bank selected ISEAS to develop the regional network in East Asia which, together with regional networks in other regions of the world, aims at promoting research capacity building and research networking among research institutions and researchers in each of the World Bank's seven developing regions. Currently, the EADN has an institutional membership of over thirty institutes in East Asia, stretching from China to Indonesia.

ISEAS receives annual grants from the World Bank to develop the network and promote network activities. Major activities of the EADN include:

- The Annual EADN Forum. The Third Forum was held in Singapore on 25-27 June 2001.
- Participation in the Global Research Project on Sources of Growth.
 The first phase of thematic studies has been completed and the second phase covering eight East Asian countries has begun.
- Participation in the Global Development Network (GDN) Forum in Rio de Janeiro in December 2001.
- Competitive awards of individual research project grants.
- The launch of two regional research projects, on "Indicators and Analyses of Vulnerabilities to Economic Crises" and "Income Distribution and Sustainable Economic Development: The East Asian Experience".

- Nomura Research Institute AT10 Network: The Tokyo-based institute co-ordinates and funds the activities of the Network, which comprises one leading research institute from each of ten East Asian economies. ISEAS participates in the annual research project and publishes the research results for Nomura. There is also an annual AT10 Presidents Meeting focusing on current developments and key issues in East Asia.
- Japan Center for International Exchange (JCIE): ISEAS co-partners JCIE in the Intellectual Dialogue on Building Asia's Tomorrow, the Asia Pacific Agenda Project (APAP), and the Council for Asia-Europe Cooperation (CAEC). The partnership has involved collaborative research projects, joint conferences, and joint publications.

Public Affairs Unit

(Co-ordinator: Mr Daljit Singh)

The Public Affairs Unit (PAU) co-ordinates publications, public forums, and briefings which do not fall directly under the three research programmes.



- Southeast Asian Affairs 2001 is an annual review of political and economic developments in the region, with contributions drawn from experts from the region or on the region.
- Regional Outlook: Southeast Asia 2002–2003 is an annual preview of anticipated economic and political trends in the region, written largely by in-house researchers.
- "Regional Outlook Forum 2002". The Regional Outlook Forum was initiated in January 1998 as part of the continuing efforts of the Institute to contribute to a greater awareness and understanding of Southeast Asia and East Asia. It is a forward-looking analysis of emerging trends, developments, and challenges by leading experts drawn from international and regional institutions and from countries in the region. The January 2002 Forum attracted some 470 paying participants. Keynote speakers were Professor Wang Gungwu, Director of the East Asian Institute at the National University of Singapore; Dr Supachai Panitchpakdi, Director-General designate of the World Trade Organization (WTO) and former Deputy Prime Minister of Thailand; and Gen (Retd) Susilo Bambang Yudhoyono, Co-ordinating Minister for Political and Security Affairs of Indonesia.

- Briefings: During the year, the Director and research staff provided numerous formal and informal briefings on economic, political, security, and social developments, trends, and challenges in Singapore, Southeast Asia, East Asia, and APEC. These briefings are provided for the following: officials of the Ministry of Foreign Affairs proceeding on overseas postings, Lee Kuan Yew Exchange visitors, members of the diplomatic corp based in Singapore, visiting delegations and individuals from international and regional organizations, academic institutions, foreign governments, funding agencies, and the media.
- The Singapore Lecture: The Singapore Lecture, inaugurated in 1980, is designed to provide an opportunity for distinguished statesmen and leaders of thought and knowledge to reach a wider audience in Singapore. The presence of such eminent personalities allows Singaporeans, especially younger executives and decision-makers in both the public and private sectors, the opportunity to hear leading world figures speak on topics of international and regional concern and interest.


apid change and use of new technologies have served as the catalyst for constant innovation. In publishing, there is now wide acceptance of content in digital form. Moving into the realm of electronic publishing has not only opened up new opportunities but has also presented new challenges. The staff of the Publications Unit have worked closely as a team to come up with new ways of doing things and new strategies — many in the forefront of use of new technologies and the Internet.

Business-to-Customer E-Commerce

Having first implemented business-to-business (B-to-B) in areas of production and supply the previous year, the next stage was to develop business-to-customer (B-to-C) e-commerce. This involved a major enhancement and upgrading of the website. Many months of planning, data entry, and implementation eventually came to fruition with the soft launch of the new website http://www.iseas.edu.sg/pub.html. This continues to be updated weekly, while fine-tuning and further enhancements are ongoing.



New and innovative services now available to customers include electronic document delivery of single book chapters or articles; entire e-journals for subscriber access by password; e-books; searches for related topics; on-line ordering; and announcements by e-mail alerts. Customer access to e-content has increased. There is thus greater dissemination of ISEAS research publications and content to a wider audience world-wide — including new customers in areas that we did not previously reach such as in Greece, Puerto Rico, Spain, Mexico, Peru, and Kuwait.



Manuscript Review Committee

All scholarly manuscripts submitted to ISEAS to be considered for publication are subjected to peer review. This practice continues and we are grateful to the many scholars and specialists who assist us by reading the works and writing reports on their publication-worthiness. For the year under review, a total of eighty-six book-length manuscripts were received from scholars all over the world.



New Books and Journals

The Publications Unit issued a total of thirty-one new publications in the year 2001/02. See Appendix VIII for the list of new books and journals, as well as Working Papers and Trends in Southeast Asia series.

Book Promotion, Marketing, and Distribution



The value-added copy-editing and production input of the Publications Unit ensures a consistently high quality of books and journals. However, even the best books need to be promoted and marketed in order to reach an audience of readers. The Publications Unit uses many ways to promote and distribute ISEAS books and journals, including:

- the print and electronic catalogue, ISEAS Books 2001/2002
- website < http://www.iseas.edu.sg/pub.html >
- thirty-three fliers sent to customers in one hundred countries
- advertisements in scholarly journals and conference programmes
- twenty-six e-mail alerts
- forty-seven book reviews in journals in Europe, United States, Australia, and Asia
- book displays at thirty-five specialist conferences, locally and abroad
- radio interviews
- promotion and sale at four international book fairs, locally and overseas.



Co-Publications

A total of nineteen books were co-published in 2001/02 with partners in Australia, United Kingdom, United States, Thailand, India, and Japan. Co-publications are a form of strategic alliances with other research institutes, universities, and publishers to issue scholarly material on Southeast Asia. Such arrangements involve permissions and rights to publish a book in different parts of the world. The advantages of co-publications include economies of scale and wider dissemination of the material through different distribution networks.

Translations

To reach a non-English-speaking audience, especially in Asia, ISEAS books are available for translation. In 2001/02, rights were negotiated for the translation of two books, one into Bahasa Indonesia and the other into Japanese.

LIBRARY

(Head: Miss Ch'ng Kim See)

he implementation of the retrofitting of the climatic air-conditioning of the Library building preoccupied a major portion of staff time during the report year. Staff also attempted to catch up on huge backlogs built up especially during the previous year, which was devoted to the development of a five-year vision plan for ISEAS Library (ISEAS Library 21), and the professional study of the causes of fungal and insect attacks on Library materials.

- ISEAS Library 21 Five-Year Vision Plan: The ISEAS Board of Trustees approved the ISEAS Library 21, a five-year perspective plan prepared by the Head of ISEAS Library and approved by the BOT Ad Hoc Library Committee set up under the chairmanship of Mr Barry Desker to study the plan that the BOT had requested the Library to propose.
- Retrofitting and Professional Study of the Library Building and Air-Conditioning System: The Library retrofitting project was the major project of the report year, from April 2001 through March 2002 inclusive. The retrofitting involved the Library's air-conditioning system, associated building works and installation of a fumigation chamber, based on professional consultancy advice and recommendations.

The Collection

The Library's collection at the end of the report year stood at 489,542 items. Processed print and microform materials totalled 365,954 items, that is, 149,934 titles, an increase of 3.6 per cent (5,162 titles) over the previous year. This excluded the partially processed audio-visual materials of 82,965 items and the backlog of unprocessed 40,623 titles of print and microform materials, which increased by 1.4 per cent over the previous year. Staff shortage also increased workload. Figures 3 and 4 (on the next page) show the details.

Serials Collection

The serials collection stood at 1,924 titles, with 131 new titles added. There were forty-six newspaper titles.

ISEAS Library Collection, as at 31 March 2002




as at 31 March 2002




As of 31 March 2002, the Library received as deposits a total of 116 pieces of research works.

Country Collections

The processed collection on the Southeast Asian region and countries rose to 96,227 titles, constituting 64 per cent, and vernacular languages of the region made up 51 per cent of the total library collection, inclusive of unprocessed titles. See Figures 5 and 6.

Computerized Databases

SEALion (Southeast Asia Library Online)

The Library's on-line public access catalogue *SEALion* (*Southeast Asia Library Online*) using the integrated library software, the *HORIZON*, and running on the Sun Enterprise 450, now has more than 157,114 records of titles.

The Institute's researchers and staff were able to access the on-line catalogue via a LAN network. Registered external users could access it remotely on the World Wide Web via *WebPAC* since its launch on 4 September 2001.

Other Databases


Several other databases in addition to the *SEALion* database continued to be developed using the *HORIZON* and other software:

- SEABase (Southeast Asia Database): This database contained indexes of journal and newspaper articles, as well as conference papers and chapters in composite works. Altogether, 162 journal titles were indexed, of which 116 were Southeast Asian titles. The total number of indexing records stood at 31,924.
- SEAText (Southeast Asia Full-Text Database): SEAText, initiated in 1997 to store and retrieve the full-text of newspaper feature articles, selected current affairs journal articles, documents, and other materials from selected websites and e-mail attachments, was developed on a windows-based client/server full-text retrieval software, the EFS Retrievalware, running on the Sun Ultra Enterprise 1 Model 170. The number of entries of full-text articles totalled 28,071.
- SEABiog (Southeast Asia Biography Database): SEABiog was developed on the *Inmagic* software in 1989. As of 31 March 1994, the total number of records in the biography database was 2,570.
- SEAPriv (Southeast Asia Private Papers Database): SEAPriv was developed on the Inmagic software to house the index of the Library's collection of private papers. The database now has 526 records of more than 16,400 items deposited in the David Marshall Papers Collection, an increase of 248 records over the previous year. The indexing of these 248 folios of about 8,400 items was done by a freelance indexer and funded with a generous grant of \$20,000 from the Lee Foundation.
- Singapore National Database: Since 1988 the Library has participated in the 64-member Singapore Integrated Library Automation Service (SILAS) database, a mutually beneficial co-operative cataloguing utility and union catalogue programme. ISEAS Library contributed 65 per cent of original cataloguing records of its unique Southeast Asian materials into the SILAS database.

Library Usage

Out of a total of 506 registered users, there were 255 new users with access periods varying from one day to one year. During the report period the number of user visits totalled 2,922. The categories of users are shown in the pie chart on the following page.

ADMINISTRATION AND COMPUTER UNIT

Administration

(Head: Mrs Y.L. Lee)

The Administration commenced the computerization of its financial systems in improving its administrative and financial practices and procedures with information technology.

It continues to carry out its wide range of administrative, accounting, budgetary, logistic, and personnel functions to support the Institute's research programmes, Library, Publications Unit, and Computer Unit.

The Singapore Government's annual grant, through the Ministry of Education, is the major source of ISEAS funding. For FY2001/02, ISEAS received an Operating Grant of \$9,968,900 and a Development Grant of \$1,993,680.

- The operating grant was about 3 per cent higher than the grant of \$9,658,000 received in FY2000/01. This marginal increase was due mainly to the incremental amount (as defined in the 4.1 per cent MIF factor) approved by the Ministry with offset from the payment of a lower variable bonus.
- The operating grant covered the cost of the physical infrastructure (building rental and maintenance), purchase and maintenance of equipment, library acquisitions and maintenance, staff salaries and some of the research and publication activities.
- The Development Grant of \$1,993,680 was used for three projects, namely, Expansion of Computer Unit, Retrofitting of Library, and IT Master Plan II.

In addition to the annual Government grant, ISEAS also received a sum of \$1,437,826 from other sources in FY2001/02. These were donations, grants, and contributions from external sources (international agencies, foundations, co-partners of research projects and conferences) and domestic private benefactors, as well as income from training programmes, public lectures, and research consultancies. The largest grant of \$0.8 million was donated by the East Asian Development Network. The monies received from the various sources helped to fund fellowships and scholarships, research projects, conferences and seminars, and some staff salaries.

The Finance Section maintains the accounts according to audit requirement, and manages the incomes and expenditures to the different units of ISEAS (namely, Administration, Research, Library, Publications, Computer) to provide accountability and transparency.

Appendix IX lists the donations, grants, contributions, and fees received.

The Institute wishes to express its appreciation to all donors and contributors for their generosity and support of its various intellectual activities.

Computer Unit

(Acting Head: Mr Natarajan Nagarajan)

The Computer Unit maintains the Institute's ATM network and the WAN connectivity to NUSNET (NUS Network for Internet), BIG (Broadband Infrastructure for Government), and SILAS (Singapore Integrated Library Automation Service).

Other services provided by the Unit include:

- Providing technical support services, including training, to the Administration, Library, Publications Unit, and Research staff, visiting researchers, and trainees
- Maintaining the Institute's hardware, databases and applications, and smart card security system
- Managing the Institute's IT budget and IT hardware and software.

The Computer Unit has completed its expansion project, thus removing the space constraint the unit had faced and allowing proper placement of the systems and a better work environment for its staff. It is currently implementing the IT Master Plan II project, which includes the installation of new servers, operating systems, and applications, and the upgrading of network and end-user PCs and peripherals. The project is expected to be completed in FY2004/05.
