## **Executive Summary**

The research work of ISEAS continued to focus on the economics, politics and societies of Southeast Asia and on the region's economic, geopolitical and cultural interactions with its broader Asian environment. Research was carried out both on a regional and individual-country basis, and often with an inter-disciplinary approach. In addition to in-house resources, ISEAS has freely drawn upon expertise from outside and collaborated with other organizations in Singapore and abroad.

Work on a regional basis centred on ASEAN, regional integration and free trade areas (FTAs). Among the noteworthy regional projects undertaken were the ASEAN Investment Area Plus research project that applied the disciplines of economics and law to formulate strategic policy instruments to facilitate ASEAN's FTA negotiations with its dialogue partners, especially in the area of investments; an ASEAN Roundtable on Revisiting the Bali Concord II which evaluated progress in regional integration to date and considered approaches to realize the ASEAN Community by 2020; a policy-oriented research project supported by the Ministry of Education on "The Role of Education in Building an ASEAN Socio-Cultural Community" that came out with a set of recommendations to reform the school curricula to create a better sense of community among the peoples of the region; and a collaborative workshop on Southeast Asian economic cooperation and pan-Asian integration.

Another project on "Language, Nation and Development in Southeast Asia" examined how language policies in the region have affected national cohesion and ethnic identity. An ongoing project on "New Politics Amidst Rising Expectations in Southeast Asia" examines how the mix of growing middle classes, Internet penetration and revolution in communications affects governance in the five founding members of ASEAN. Research interest in ageing in Southeast Asia continues, with ongoing preparations for a new workshop on financing ageing societies in Southeast Asia. Other important regional issues and concerns examined through seminars and forums included maritime security and energy security.

As for ASEAN's interactions with its broader Asian environment, the engagement of the major powers with Southeast Asia has been a subject of abiding interest and importance for ISEAS, leading to many seminar activities, including on the rise of maritime power in the Indian Ocean and East Asia. A conference was held to examine the present status, challenges and prospects with regard to economic linkages with China, and the papers were published as an edited volume. There have also been a number of other publications, based on workshops or research on economic, political or security relations with China, India, and Korea, among others.

The attention to regional studies did not mean a diminution of individual country studies. There were

numerous seminars and discussions on political, economic or security developments within specific Southeast Asian states. Among the highlights of country studies was the publication of the book The Reluctant Politician: Tun Dr Ismail and His Time, a political biography of the late Malaysian Deputy Prime Minster, which has generated a high level of interest in both Malaysia and Singapore. Other significant country-focused activities included a conference examining the challenges facing the Malaysian economy in the medium to long term and potential new areas of growth; and a conference on the Philippines that included an examination and assessment of that country's political and security situation, as well as its economic performance and prospects. The annual "Myanmar/Burma Update" and the "Vietnam Update" continued to be held in collaboration with the Australian National University. These two country studies enjoy a high standing among the international scholarly community. On Singapore, ISEAS has a project to do biographies of Singapore's first-generation leaders who led the country in the early years of independence.

ISEAS continues to expand its inter-disciplinary as well as multi-disciplinary approach in its research agenda so as to encourage more creative interactions among researchers, wider engagement of the research communities in Singapore and the region, as well as more holistic ways of tackling today's complex issues and problems. Among the

subjects lending themselves to inter-disciplinary approach are ASEAN community building, conflict management and resolution, leadership transition and political change, human security and development, environment and natural resources, gender studies, energy studies and population dynamics and development.

Public outreach activities of the Institute in the form of public lectures, forums and seminars remained at a high frequency, continuing to absorb considerable time of both the research and non-research staff who are involved in their organization. But the effort has paid off in terms of much greater interest on the part of the wider public to participate in ISEAS intellectual life in recent years. Among the highlights of public outreach activities during the year were the 28th Singapore Lecture on "Opportunities and Challenges for Asian-Arabian Ties" by His Royal Highness Prince Sultan bin Abdul Aziz Al-Saud. the Crown Prince and Deputy Prime Minster, Kingdom of Saudi Arabia, on 11 April 2006; and the Regional Outlook Forum held in early January to survey the political, security and economic outlook for Southeast Asia, which saw an attendance of over 500 people from the private corporate sector, the diplomatic corps, academia and the public sector.

Meanwhile ISEAS has continued to produce its three journals (Contemporary Southeast Asia, the

ASEAN Economic Bulletin, and SOJOURN) as well as the annual Southeast Asian Affairs. These publications, together with the research output in the form of books, have maintained the reputation of ISEAS in Southeast Asian studies. In recent years ISEAS has published or co-published an average of over 50 new book titles per year. Among the

best-selling books in 2006–2007 were Voices of Islam in Southeast Asia: A Contemporary Sourcebook, compiled and edited by Greg Fealy and Virginia Hooker; The Reluctant Politician: Dr Ismail and His Time, by Ooi Kee Beng; and Southeast Asia in Search of an ASEAN Community, by Rodolfo C. Severino.

## **Mission Statement**

The Institute of Southeast Asian Studies (ISEAS) was established as an autonomous organization in 1968. It is a regional research centre dedicated to the study of socio-political, security, and economic trends and developments in Southeast Asia and its wider geostrategic and economic environment.

In addition to stimulating research and debate within scholarly circles, ISEAS endeavours to enhance public awareness of the region and facilitate the search for viable solutions to the varied problems confronting the region.

The Institute is strategically placed to assist international, regional, and local scholars and other

researchers in the networking process by serving as a centre that provides a congenial and stimulating intellectual environment, encouraging the fullest interaction and exchange of ideas in an unfettered ambience. ISEAS is dedicated to long-term reflective analysis and investigation in the best traditions of scholarship. The Institute also seeks to stimulate thinking on, and exploring solutions to, some of the major salient issues in the region.

To achieve these aims, the Institute conducts a range of research programmes; holds conferences, workshops, lectures, and seminars; publishes research journals and books; and generally provides a range of research support facilities, including a large library collection.



## **Research Programmes and Activities**

he research programmes and activities at ISEAS are carried out by a core group of research staff as well as by a larger group of visiting scholars, researchers, and affiliates. The research and related activities of the Institute are grouped under three research programmes — Regional Economic Studies (RES), Regional Strategic and Political Studies (RSPS), and Regional Social and Cultural Studies (RSCS), and the Inter- and Multi-disciplinary Research Clusters.

### **Research Staff**

The Director, assisted by the Deputy Director, oversees the work of 29 researchers (professorial fellow, senior fellows, senior research fellows. fellows, and research associates) during the year. The research staff are engaged in numerous

activities besides group and individual research. They function as coordinators and organizers of research projects, training programmes, conferences, public lectures, and seminars; editors and referees of ISEAS journals, working papers, and book publications; resource persons for briefings; as well as liaising with visiting researchers and scholars.

## Visiting Researchers and Affiliates

ISEAS played host to about 92 researchers and scholars in FY2006/07. The lists of visiting researchers and affiliates are given in Appendix II. They fall into the following categories:

(a) Visiting research fellows on ISEAS stipends or ISEAS-administered grants. These vary




in seniority and duration of attachments and include the Professorial Fellow, Visiting Professorial Fellows, Visiting Senior Research Fellows, Visiting Senior Fellows, and Visiting Research Fellows.

- (b) Visiting researchers and scholars not on ISEAS stipends or ISEAS-administered grants. They are either self-funded or funded by various foundations and grants. The Institute offers them a range of research
- facilities, ranging from office space to library facilities.
- (c) Associate fellowships, without remuneration, are offered to former ISEAS staff researchers, as well as some academic staff from the National University of Singapore and Nanyang Technological University. Such affiliation enables these academics to participate in ISEAS research and training projects and to use the Institute as the base for their continuing research.

# Regional Economic Studies (RES) Programme

(Coordinator: Dr Denis Hew)

The Regional Economic Studies (RES) programme focuses on a broad range of economic issues in the Asia-Pacific region, with a special emphasis on the Association of Southeast Asian Nations (ASEAN). The programme covers a variety of research and research-related activities from workshops, conferences, seminars, training programmes, to the publication of journals and articles and includes partnerships with other research institutions, universities and development organizations.

The RES programme incorporates the Trade Policy Unit (TPU). The TPU was established in

2003 to undertake research on trade policy issues particularly related to the World Trade Organization, and from a Southeast Asian perspective. Activities of the TPU include publishing trade policy papers, organizing workshops, roundtables and seminars, and collaborating with other institutions involved in trade policy.

- brought together a high-powered group of academics and experts on the Philippines who provided knowledgeable and provocative assessments of key political, economic, and social issues facing the country. Papers emanating from this conference will be published as an edited volume.
- ASEAN Roundtable 2006 on "Revisiting the Bali Concord". For details see Inter- and Multidisciplinary Research Clusters.
- "His Majesty the King and Development of Thailand". The seminar examined the King of Thailand's development projects during the past sixty years of his reign. In conjunction with the seminar, ISEAS and the Royal Thai Embassy launched two exhibitions "Ode to Friendship: Celebrating Thailand-Singapore Relationships" and "The 60th Anniversary Celebration of HM King Bhumibol Adulyadej's Accession to the Throne".

- The two exhibitions were displayed at the ISEAS Library. The seminar was held on 14 August 2006.
- Policy Workshop on "South Asia-East Asia Cooperation and Pan Asian Integration". The workshop examined trends in pan-Asian economic integration and reviewed future options for closer cooperation between East Asia and South Asia. This workshop was held on 29–30 November 2006 and co-organized with the Asian Development Bank (ADB), Singapore Centre for Applied and Policy Economics (SCAPE) National University of Singapore, and Research and Information Systems for Developing Countries (RIS), New Delhi.
- "The Malaysian Economy: Development and Challenges". The Ninth Malaysia Plan and the Third Industrial Master Plan, which were both launched in 2007, serve as important building blocks to achieve Malaysia's goal of becoming a developed country by 2020. A conference to examine the main challenges facing the Malaysian economy in the medium to long term (especially in the light of recent concerns with regards to Malaysia's declining competitiveness) as well as to discuss potential new sources of economic growth was held on 25-26 January 2007. Papers emanating from this conference will be published as an edited volume.
- Seminar on "The Free Trade Area of the Asia Pacific (FTAAP) and Managing the Asia-Pacific Supply Chain". The proposal for a free trade area of the Asia-Pacific or FTAAP emerged in 2004 in the form of the APEC Business Advisory Council (ABAC)'s recommendation to the APEC leaders as an alternative means to achieve trade liberalization. The seminar examined the objectives, modalities, and impact of the FTAAP agenda and its relevance for businesses in the Asia-Pacific region. The seminar was held on 19 March 2007 and co-organized with the Singapore APEC Study Centre, Singapore Business Federation (SBF), and the Pacific Economic Cooperation Council (PECC) Secretariat.

ASEAN Economic Bulletin (AEB) is the Institute's economics journal. Launched by ISEAS in July 1984, the AEB focuses on policy-relevant economic issues affecting ASEAN or its member countries. Three issues are published each year. A special focus issue entitled Riding Along a Bumpy Road: Indonesian Economy in an Emerging Democratic Era, edited by Aris Ananta and Yohanes Eko Riyanto was published in April 2006.

## ISEAS Trade Policy Unit (Coordinator: Dr Rahul Sen)

The Trade Policy Unit (TPU) was established in September 2003 to undertake research on trade policy issues particularly related to the World Trade Organization (WTO), and from a Southeast Asian perspective. The findings would serve to highlight their implications for ASEAN economies. The TPU serves to keep the public informed on the developments in the WTO. The unit collaborates with like-minded institutions and individuals in the region and beyond to enhance the understanding of policy issues relating to trade and trade-related matters in Southeast Asia and beyond.

The TPU has collaborated with the following institutions: London School of Economics' Global Dimensions, Commonwealth Business Council (CBC), Federal Trust and SITPRO UK.

The Unit also published a series under the title "WTO Issues".

#### Research Activities in 2006/07

In 2006, the Unit was involved in collaborating with Asian Development Bank's Office of Regional Economic Integration, by participating in a Brainstorming Workshop on designing and implementing effective FTAs in Asia. A policy workshop on pan-Asian integration was also held in joint collaboration with ADB and the Research

and Information System for Developing Countries (RIS) in November 2006.

The TPU has also been frequently sought in 2006–07 for briefings from the diplomatic community and the print and broadcasting media for views on trade policy issues in Southeast Asia. Delegations from Australia, Korea, New Zealand, India, the United Kingdom, France, Japan, and Sweden have had discussions with members of the unit, particularly with a focus on proliferation of Regional Trading Agreements and current efforts at ASEAN and pan-Asian economic integration.

In 2007, TPU researchers plan to continue the work on FTAs with a greater focus on sectoral impact issues, and to a larger extent, on services trade. A researcher from this Unit was invited to participate at the deliberations of the ASEAN Economic Forum meeting in Manila, Philippines, organized by the World Bank Institute, Geneva. The Unit has also recently established links with the newly set up European Centre for International Political Economy in Brussels, Belgium and plans to collaborate in the Asia focused activities of the centre in 2007–08.

The TPU is working closely with the Singapore APEC Study Centre at ISEAS to track trade policy developments not just in Asia, but also across the Pacific.

# Regional Strategic and Political Studies (RSPS) Programme

(Coordinator: Dr David Koh)

The Regional Strategic and Political Studies Programme in 2006 continued to focus on two major areas — the strategy and politics of the region. The engagement of major powers in the region and the construction of a new regional architecture in East Asia have important impacts on peace and stability in Southeast Asia, a topic on which the RSPS organized many seminar activities. In particular we organized a workshop on India and Indians in Southeast Asia, two seminars on India as a rising great power and Chinese foreign relations, and two seminars on the rise of maritime power in East Asia in the 21st century and Russian naval strategy in its Far East. In 2006 the politics of Southeast Asia experienced a shake-up when the military coup in Thailand on 19 September challenged many assumptions and supposed knowledge about the progress of democracy in Southeast Asia. On the situation in Thailand the

RSPS programme organized two seminars after the coup to shed light on the future of the country. The national politics or other countries were not neglected, however. The Programme organized numerous workshops and seminars on domestic political developments, including:

 Forum on "New Politics Amidst Rising Expectations in Southeast Asia", a research project that grew out of a suggestion by the ISEAS International Advisory Panel. Cognizant of the vast socio-economic changes sweeping through the region, the project examines how growing middle-classes, the audio-visual revolution, and increasing Internet penetration, to mention a few of these changes, have impacted governance in five Southeast Asian countries — Indonesia, Malaysia, the Philippines, Singapore, and Thailand.

- "The Asian Mediators' Retreat" that was jointly organized by the Henri Dunant Centre and ISEAS for the second year running. This retreat brought together the actors and mediators involved in national armed conflicts of the region to explore new ways of resolving conflicts and to share their experiences.
- Seminar on "S. Rajaratnam as I Knew Him".
   As Singapore matures it is natural for it to remember its pioneers. Former Foreign

Minister of Singapore S. Rajaratnam passed away in 2006, and Mr Lee Khoon Choy delivered the seminar to remember one of Singapore's founding fathers. ISEAS has also been delving more into Singapore's past, such as organizing a workshop on the Indian National Army and the role of Singapore; and a book project by Dr Leon Comber on the role of the Special Branch in containing the Malayan Communist uprising.

The RSPS has two flagship publications. The journal *Contemporary Southeast Asia* continues to provide a platform for the analysis of regional political and security issues. In a similar role is *Southeast Asian Affairs*, the single most important regional publication providing annual analyses and reviews of national politics and regional developments of Southeast Asia.

Focused on social and cultural issues in the region, the RSCS programme has engaged topics such

as globalization, nation-building, civil society, ethnicity, education, Internet, ageing, migration, and gender. It produces the half-yearly academic journal *SOJOURN*. In recent years, the programme has broadened the scope of research to include performative items on its cultural agenda, examples of which include dance workshops and the screening of films. It has also initiated a modest project to fund the making of documentaries on Southeast Asia.

## **Major Projects**

 The Reluctant Politician: Tun Dr Ismail and His Time is a political biography of the late Malaysia Deputy Prime Minister written by RSCS Fellow Dr Ooi Kee Beng. The research — based on Tun Ismail's private papers deposited in the ISEAS Library and numerous interviews with his relatives and people who knew him — and the writing took fifteen months. The book was published in December 2006 and has generated a high level of media coverage in both Malaysian and Singapore. Malay and Chinese editions are in the pipeline.

 "The Role of Education in Building an ASEAN Socio-Cultural Community" is an attempt at policy-oriented research. Scholars in the region examined how school curricula in the ASEAN countries can be reformed to create a better sense of community among the people in this region. The project, coordinated by Dr Terence Chong and supported by the Ministry of Education, produced a set of policy recommendations.

- Editing of the papers from the "Workshop on Ageing and the Status of Older Persons in Southeast Asia" project has been completed and the manuscript submitted for production. Meanwhile the research interest in ageing continues and work has started on a three-day "International Workshop on Financing Ageing Societies in Southeast Asia" scheduled for September 2007.
- "Language, Nation and Development in Southeast Asia" looks at language policy in various regional countries posing questions such as how was a national language chosen and how has the language policy affected national cohesion and ethnic identity. Editing work on the research output has been completed and the publication can be expected sometime in 2007.
- Sight&Sound@ISEAS is a project launched by the RSCS programme in 2003 to go beyond the researching culture to highlighting the performative feature. Since then it has promoted films, dance, and exhibition. For the past year, performance items included Baliyatra (a drama fusing Indian and Balinese dance styles); Cherita Singapura (Singapore

Karno" on the late Indonesian President Soekarno was shown. There was also a "World Religions-Universal Peace-Global Ethics" exhibition.

 ISEAS Film Project. In a multimedia age, research output need not be just printed text.
 Research findings can also be presented as videos/films. To encourage this trend, a pilot film funding project has been launched with the financing of two thought-provoking documentaries. The first, *I Love Malaya*, on Malaysian/Singapore Communist cadres living in exile in southern Thailand has been completed and screened. It poses the question, should these people be allowed back to their countries unconditionally? The second, *Invisible City* by renowned Singapore film-maker Tan Pin Pin, examines how the

The RSCS programme publishes the *Journal of Social Issues in Southeast Asia*, otherwise known as *SOJOURN*, twice a year. The youngest of the Institute's three academic journals, it was launched in 1986.

## **ASEAN and the Dialogue Partners**

ISEAS has been giving attention to ASEAN's relations with the dialogue partners, which constitute an important aspect of the region's open engagement with the world beyond. There is a recognition that these evolving relationships should be guided by sound research, good understanding and by the development of a network of collaborating researchers as well as policy-makers who could further the relationships. Towards this end ISEAS has organized seminars, workshops, conferences, and public forums and disseminated reports and various publications on a number of the ASEAN dialogue relationships notably, with China, India, Japan, Korea, Russia, Australia, New Zealand, and the EU. The focus has been on the political, strategic, economic and sociocultural aspects of the relationships. Other dialogue relationships will be revisited as we transit 2007.

## Inter- and Multi-disciplinary Research Clusters

## (Under the general overview of Dr Chin Kin Wah)

While ISEAS continues to pursue in-depth country studies with special emphasis on Malaysia, Indonesia, Thailand, the Philippines, Myanmar, and Vietnam, it continues its sharper inter-disciplinary, as well as multi-disciplinary, focus into its research agenda. This is intended to facilitate more creative interactions among the existing researchers at ISEAS and to encourage wider engagement of the research communities in Singapore and the region while facilitating a more holistic approach towards understanding complex issues and problems. Identifying these clusters within a clearly defined Southeast Asian context will also help the research community outside ISEAS to know about possible areas of research collaboration.

With this approach to research, ISEAS hopes to increase the number of comparative and integrative studies in its programme.

Work already completed or in progress:

# ASEAN Community-building (Coordinator: Dr Denis Hew)

 "ASEAN Investment Area Plus" Research Project. ASEAN is currently negotiating free trade agreements (FTA) with its dialogue partners, particularly China, Japan, Republic of Korea, India and CER (Australia and New Zealand). ISEAS undertook a major study that applies two disciplines — economics and law — to formulate strategic policy instruments for the purpose of ASEAN's FTA negotiations with its dialogue partners, specifically in the area of investment. Funded by the ASEAN-Australian Development Cooperation Programme's Regional Economic Policy Support Facility (REPSF), the study was completed on 18 December 2006.

- "European Experience of Regional Integration: Sharing of Experiences". This seminar brought together academics and relevant experts to examine and compare European and Southeast Asian economic integration experiences. The seminar was held on 24 April 2006.
- ASEAN Roundtable 2006 on "Revisiting the Bali Concord II". More than three years have past since the ASEAN Concord II (or better known as the Bali Concord II) was first launched. The ASEAN Roundtable 2006 brought together academics and experts to take stock of what has been done to date in

regional integration and to discuss approaches to realize the ASEAN Community by 2020. The roundtable was held on 24–25 August 2006. A report on the roundtable was published on 5 December 2006.

## Population Dynamics and Development

(Coordinator: Dr Aris Ananta)

The project examines how natural disasters affected Indonesia's population size and composition as well as the economic, social, and political consequences on the population. Within this frame of reference, Aceh received the largest attention, covering not only the natural disaster—hit areas, but also the conflict-torn areas. The research on Aceh records among other things the contribution of Singapore to the tsunami-affected areas in Aceh. This research has resulted in a book *Aceh: A New Dawn*, edited by Aris Ananta and Lee Poh Onn.

The research also covers the May 2006 devastating earthquake in Yogyakarta, and some other natural disasters in the island of Java. Aris Ananta paid special attention to the population of Yogyakarta, particularly with respect to the Javanese culture and its social and political implications. He made a presentation at an ISEAS public lecture on "Natural Disaster Prone Indonesia with special focus on Yogyakarta", on 27 June 2006. He gave a live interview in the Prime Time Morning programme on Channel News Asia International on "Natural Disaster in Indonesia", on 28 June 2006.

#### Migration and violent conflicts

Dr Aris Ananta was guest editor of a special volume on "Migration and Violent Conflicts in Southeast Asia", *Population Review*, Vol. 45, No. 1, 2006. He also contributed a paper entitled "Changing Ethnic Composition and Potential Violent Conflict in Riau Archipelago, Indonesia: An Early Warning Signal".

### Demographic changes and democracy

A possible linkage between demographic transition and demand for democracy, particularly as related to the occurrence of the second demographic transition was investigated by Dr Aris Ananta who used Indonesia as an illustration in his article "Commentary. Demand for Democracy in Indonesia: A demographic perspective", which appeared in *Asian Population Studies*, Vol. 2, No. 1, March 2006.

Dr Ananta also examined the demographic patterns of conflict-torn and natural disaster–hit communities in Aceh. Part of the study has been published as a chapter "The Population and Conflicts" in *Aceh: A New Dawn*.

ISEAS is currently collaborating with Arnold-Bergstraesser Institut (ABI) Freiburg in a study on "Migration and Democratization in Southeast Asia and Europe". This is a relatively new interdisciplinary study, involving scholars from various disciplines — economics, demography, sociology, political science, and philosophy. Dr Aris Ananta is the coordinator for the participants from Southeast Asia.

## Environment and Natural Resources Cluster

(Coordinator: Dr Lee Poh Onn)

Under this cluster, several projects have been undertaken. The book *Aceh: A New Dawn*, referred to earlier, covered the impact of a natural environmental disaster in a particular area and how government entities and Singapore non-government organizations (NGOs) have subsequently assisted with rehabilitating and reconstructing the area in the post-tsunami period.

The study on forest management issues in Sarawak and the region has also been ongoing. Related to forest management issues in Sarawak, Malaysia, the study on the Bakun Dam in Sarawak, Malaysia, is another research project being undertaken.

Water management issues (present trends and future directions) in the region and in Singapore continue to be an important area of research under this cluster. In particular, Singapore's utilization of new technologies to harness recycled and sea water for consumption will be the focus in the year to come.

## Human Security and Development Cluster

(Coordinator: Dr Tin Maung Maung Than)

Editing of the revised papers, initially presented at the multi-disciplinary ASEAN Roundtable 2005

on "The Asian Tsunamis: Implications on Regional Development and Security" held on 17–18

November 2005, was carried out by Dr Denis Hew and Ms Sanchita Basu Das. The resulting edited volume is expected to be published in 2007.

A paper presented by Dr Tin Maung Maung Than at the Workshop on "Myanmar Peace Initiative", held in Hiroshima, on 26–28 October 2005, was further revised and published as a chapter entitled, "Mapping the Contours of Human Security Challenges in Myanmar", in *Myanmar: State, Society and Ethnicity*, edited by N. Ganesan and Kyaw Yin Hlaing.

Dr Tin also presented a paper entitled "The Future of Democracy and Human Security in Myanmar: Haunted by the Past" at the ISIS 25th Anniversary Conference on Democracy and Human Security in Southeast Asia, in Bangkok (27–28 October 2006).

### **Energy Studies Cluster**

(Coordinator: Mr Mark Hong)

Singapore is setting up an Energy Studies Centre next year to look into how competition for energy sources is influencing policies and strategies of major energy suppliers and consumers. As Deputy Prime Minister Professor S. Jayakumar has indicated, at the Singapore Energy Conference 2006 organized by ISEAS, Singapore, being an oil and gas importer, is acutely aware of the challenges posed by energy supply and security.

Reflecting the surging interest in energy and energy-related issues, the ISEAS Energy Programme organized 27 well-attended seminars between April 2006 and March 2007.

Multi-disciplinary Approach

A number of seminar topics reflected a multidisciplinary approach. They include:

- "Balance between Energy and Environment in Singapore" on 27 June 2007, by Mr Wilson Ang, President of Eco-Singapore (Energy and the Environment).
- "Advanced Portable Batteries" by Dr Robert Hamlen, former Chief of Power Division, U.S. Army (Energy and Chemistry).
- "The Bulk Shipping Markets" by Ms Louisa
   Follis on 30 August 2006 (Energy and Maritime Transport).
- "Nuclear Power-Implications for Southeast Asia" by Dr Tin Maung Maung Than on 10 January 2007 (Energy and Nuclear Physics).
- "The Straits of Malacca" by Dato K.W. Cheah on 31 January 2007 (Energy and Maritime Transport).
- "Oil Trading in Singapore" by Sam Owen and Henry Kwok on 21 March 2007 (Energy and Business).

Notable achievements include the Inaugural Singapore Energy Conference held on 8–9 November 2006 and the subsequent Report which was issued after the conference. Secondly, the ISEAS book *Energy Perspectives on Singapore* and the Region was published in March/April 2007. Thirdly, we are awaiting another book, consisting of conference papers from the Bay of Bengal Energy Conference, held in September 2006. This book is edited by Mr Sudhir Devare.

The list of topics covered in the ISEAS *Energy*Perspectives book as well as the issues dealt with in the 2006 Singapore Energy Conference display the same multi-disciplinary approach.

#### Gender Studies Cluster

(Coordinator: Ms Braema Mathiaparanam)

The major focus of the cluster is on issues related to gender equity, sustainable development and the impact on public policies within Southeast Asia as a primary focus. These issues are examined through the goals set in the Millennium Development Goals, Beijing Platform for Action, Convention on the Elimination of All Forms of Discrimination Against Women, ASEAN's Task Forces and through development and gender theories. Mr Carlos P. Medina, Jr., Secretary General, Working Group for an ASEAN Human Rights Mechanism; Mr Yap Swee Seng, Executive Director, SUARAM, Malaysia; and Professor Thio Li-Ann, Law Faculty, National University of Singapore spoke at the seminar on "The Prospects and Challenges of Human Rights in ASEAN" held on 28 August 2006.

A two-day forum entitled "Post-Beijing: Gender Issues in Southeast Asia — Have Women Moved Up. On or Out?" was held on 13-14 November 2006 with the support of the Konrad Adenauer Stiftung (KAS). The papers have since been reproduced in the journal Panorama produced by KAS. The coordinator Ms Braema Mathiaparanam was also the ISEAS consultant for a report, entitled "Substantive Review of the HIV/Aids Policies and Assessment of Current Interventions" undertaken by Agencies in Singapore for the Commonwealth Secretariat. ISEAS presented this report at the joint ASEAN Commonwealth Secretariat Workshop on HIV/Aids held in February 2007 in Kuala Lumpur. Ms Mathiaparanam was a participant on the Chevening Fellowship (Gender, Social Justice and Citizenship) at the University College of London. The three-month study stint was funded by the British Council.

### Researchers' In-house Seminars

(Coordinator: Dr Chin Kin Wah)

The researchers' in-house seminars series, which was started in July 2005, was intended to provide an opportunity for researchers to meet on a monthly basis to share research ideas and critique ongoing research work. It was felt that researchers needed to develop an awareness of what fellow colleagues were working on and interact more frequently on the intellectual plane. Thirteen generally well-attended in-house seminars have been held, featuring Miss Ch'ng Kim See, Dr K.S. Nathan, Mr Daljit Singh,

### Regional Networks

ISEAS continues to network extensively with academic institutions, individual scholars, and researchers, and regional and multilateral institutions and groupings not only in Southeast Asia but also in Northeast Asia, South Asia, the Indian Ocean Rim, Western Europe, North America, and Latin America. Networking takes many forms — ISEAS membership of formal networks; foreign participation in ISEAS conferences, workshops, seminars, and publications; joint organization of conferences and seminars either in Singapore or overseas; and the ISEAS Director and research staff participating in joint research projects and in overseas conferences and workshops.

# The Singapore APEC Study Centre (Coordinator: Dr Lee Poh Onn)

The APEC Study Centre in Singapore was established in 1994 at ISEAS by the Ministry of Education. Ambassador K. Kesavapany, Director of ISEAS, is concurrently the Director of the Singapore APEC Study Centre. Dr Lee Poh Onn (Fellow, ISEAS) is the coordinator and assists

Ambassador Kesavapany in the non-executive day-to-day running of the Singapore APEC Study Centre. The secretariat functions are undertaken by the administrative staff at ISEAS.

#### Activities

The APEC Study Centre continued liaising with other APEC Study Centres in the region, and also the APEC Secretariat, Pacific Economic Cooperation Council (PECC), and the Singapore Business Federation (SBF) to build up our network and links. The Director of the Singapore APEC Study Centre, Ambassador Kesavapany, continued to maintain close working links with the Executive Director of the APEC Secretariat 2006, Ambassador Tran Trong Toan, and also the Deputy Executive Director 2007, Ambassador Colin S. Haseltine. The centre receives regular newsletters on the APEC Economies from the Australia-Japan Research Centre at the Australian National University. It has also been networking with the Information Manager, Ms Gopika Gopalakrishnan, of the APEC Secretariat and facilitated a working arrangement whereby researchers and staff from ISEAS can use the library facilities at the Secretariat and vice versa.

Dr Lee Poh Onn attended the APEC Study
Center Consortium Conference 2006 (ASCC),
"Strengthening Economic Partnership for
Sustainable and Equitable Development in the
Asia-Pacific", from 22 to 24 May 2006, at Ho Chi
Minh City, Vietnam. Professor Christopher Findlay,

Professor of Economics and Head, School of Economics, University of Adelaide, and Vice-Chair, Australian Pacific Economic Cooperation
Committee (AUSPECC) presented a seminar on "Emerging Issues for Supply Chain Security" on 7 June 2006, at ISEAS, covering the efforts to "secure trade" in APEC economies, given the complexity of supply chains and the number of countries involved at the various stages of production.

Dr Denis Hew, Coordinator and Senior Fellow of the Regional Economic Studies Programme at ISEAS, attended the Preliminary Conference for APEC 2007 "Reshaping APEC for the Asia Pacific Century — Priorities and Strategies", which was held in Melbourne from 11 to 12 December 2006. Dr Hew also presented a paper at the seminar on Asia-Pacific regional economic integration from a Southeast Asian perspective at the National Centre for APEC, USA in March 2007 and published a commentary in the *Straits Times* (8 March 2007) on "Hurdles Ahead for the Asia-Pacific FTA".

APEC is at the crossroads at the moment.

The APEC 2007 agenda involves revitalizing structural reforms in the regional economy, which includes the proposal to set up an APEC Free Trade Agreement, energy security, and APEC administrative reforms. In view of such challenges, the Singapore APEC Study Centre at ISEAS together with the SBF and PECC jointly organized

a Public Seminar on "The Free Trade Agreement of the Asia-Pacific (FTAAP) and Managing the Asia-Pacific Supply Chain" on 19 March 2007. Associate Professor Robert Scollay, Director of the New Zealand APEC Study Centre at the University of Auckland, and Mr Teng Theng Dar, CEO of Intraco Limited, Singapore, were the speakers. The discussant was Dr Rahul Sen, Fellow at ISEAS.

Many ISEAS publications, though not specifically labelled as "APEC specific", support the APEC initiative on trade security, corruption issues, free trade and regional economic integration as these publications and work focus on the various APEC economies in Southeast and East Asia. # Biographies of Singapore's First Generation Leaders

This project on "The First Generation Leaders of Singapore Who Led Singapore in Its Early Years of Independence" will document the lives and work of former leaders — often referred to as members of the Old Guard. While there are articles and book chapters on these first-generation leaders and collections of their writings, book-length records of their lives and work are missing, and the ISEAS Biography Project seeks to fill that gap. The scholars undertaking the projects would cover the valuable contribution of Singapore's early leaders. Among other things, the project will contribute to

the understanding of Singapore and its perception of its own vulnerability despite its success at home and abroad.

The first in the series is entitled "Revolutionary Sage: Life and Legacy of S. Rajaratnam", Singapore's Foreign Minister and Senior Minister till 1988. It is authored by Ms Irene Ng.

The second is on Lim Kim San, "The Entrepreneuer-Politician", one of Singapore's most durable and respected statesmen who was also a notable businessman and politician — Mr Lim held several cabinet posts: National Development, Defence, Communications, Environment, and Education.

The third is on Dr Toh Chin Chye. Dr Toh was among the founder members with the People's Action Party (PAP) and was its chairman from its formation in 1951 to 1981. He held several cabinet portfolios including Deputy Prime Minister (1959 to 1968), Minister for Science and Technology (from 1968 to 1975) and Minister for Health (from 1975 to 1981). He was also the University of Singapore's Vice-Chancellor and the Chairman of Singapore Polytechnic.

# Research Fellowship on Southeast Asia with East-West Center, Hawaii

A two-year fellowship programme with the East-West Center, Hawaii launched in 2004 was renewed for a further two years. Past awards were made to Dr Joseph Liow Chinyong of the Institute of Defence and Strategic Studies in Singapore. Dr Chandra-nuj Mahakanjana of National Institute of Development Administration in Bangkok, Dr Kyaw Yin Hlaing of the Department of Political Science of the National University of Singapore, who spent a few months of fieldwork in Southeast Asia, at ISEAS and some months of residence in Washington, D.C. The three latest awards were made to Dr Sulfikar Amir of the Graduate Program of Development Studies of the Institut Teknologi Bandung, Dr Ardeth Maung Thawnghmung of the Political Science Department of the University of Massachusetts, and Dr Napisa Waitoolkiat, an independent researcher. The awards are jointly funded by ISEAS and the Henry Luce Foundation to the East-West Center. Monographs or articles from the awardees will be published in a peerreviewed outlet.

# Tun Dato Sir Cheng Lock Tan Scholarship

Since 1994, ISEAS has been administering the Tun Dato Sir Cheng Lock Tan M.A. Scholarship Programme, funded from the Tun Dato Sir Cheng Lock Tan Trust Fund. The Scholarship scheme is intended to provide deserving young Singaporeans with the opportunity to pursue postgraduate studies locally and overseas in the areas of politics, international relations, economics, and sociology.

## **Public Affairs Unit**

(Head: Mr Tan Keng Jin)

The Public Affairs Unit (PAU) promotes ISEAS's profile locally and internationally. It cultivates and liaises with members of the media; organizes briefings for visiting government officials; publicizes and promotes events; establishes and nurtures networks, and spearheads ISEAS support activities. In addition to the Unit's coordination of

public forums, lectures, and events that do not fall directly under RSPS, RES, RSCS, and the Interand Multi-disciplinary Research Clusters, it often assists and augments the promotional and publicity efforts of the aforementioned programmes. It too has jointly organized a country dialogue — the Southeast Asia–New Zealand Dialogue.

# **Highlights of Activities** *Regional Outlook Forum*

ISEAS' annual flagship event, the "Regional Outlook Forum 2007", held in early January, a survey of the political, security and economic outlook in Southeast Asia, is a joint effort of most researchers of RSPS and RES. This Forum is meant to give the general public an assessment of the outlook for the region as well as for selected individual countries of Southeast Asia. The 2007 Regional

Outlook Forum provided an assessment of religious extremism in Southeast Asia, a review of strategic developments in East Asia, the outlook for major Southeast Asian economies, an analysis of economic and social ramifications of the haze, an examination of political trends in Thailand, Malaysia, Indonesia, and Myanmar, and traced the scope and extent of terrorism in Southeast Asia. The Public Affairs Unit concentrated on publicizing the event as well as obtaining support for the function — it secured the support and backing

of the Hong Kong Economic and Trade Office, COSCO Corporation (Singapore), SembCorp Parks Management, and Universitas 21 Global. This Forum, like most other important conferences, was webcasted. A Summary Report of the Forum has also been published.

### **Briefings**

During the year ISEAS fellows and visiting fellows delivered a total of 69 formal and informal briefings

to visiting academics, government officials, diplomats, research officers, various ministries and postgraduate and undergraduate students. They also gave lectures externally at junior colleges, secondary schools, civil service institutions, and other organizations.

## The Singapore Lecture

The Singapore Lecture provides Singapore residents from the public sector, business

community, diplomatic corps, and academic community the opportunity to hear eminent leaders speak on topics of international and regional concerns. The 28th Singapore Lecture was delivered by His Royal Highness Prince Sultan Bin Abdul Aziz Al-Saud, Crown Prince and Deputy Prime Minister, Kingdom of Saudi Arabia entitled "Opportunities and Challenges for Asian-Arabian Ties" on 11 April 2006.

### Public Lectures and Forums

Public Lectures are another platform for other politicians, prominent academics and individuals to share their opinions on specific topics. There were seven such lectures delivered in the year:

- In May 2006, Mr Robert A. Hefner III, Founder and Owner of The GHK Company, presented his views on "The Age of Energy Gases: Asia's Opportunity".
- In July 2006, the Straits Times Global Forum brought together journalists of the Singapore Press Holdings — from its headquarters as well as its outstation post and cities local academics, ISEAS researchers, other journalists and business leaders to share their views on developments in the region.
- Also in July 2006, Dr Shashi Tharoor, Under Secretary-General, United Nations, shared his vision of "The Future of the United Nations", at a Public Lecture jointly organized with Asia Media Information

- and Communication Centre and the UN Association of Singapore.
- In August 2006, ISEAS held a seminar on "The Forgotten Army in a World at War: Subhas Bose's INA and Its Effect on Asia's Independence". Minister Tharman Shanmugaratnam, Minister for Education (Singapore) delivered the Opening Speech. This was followed by presentations from Professor Sugata Bose from Harvard University, Mr Prasenjit K Basu, and Professor A. Mani. This seminar was sponsored by ORION and supported by Singapore Indian Chamber of Commerce and Industry.
- In October 2006, HE Václav Klaus, President of the Czech Republic, presented a lecture entitled "Reflections on European Integration". ISEAS, ASEF, and the Czech Embassy jointly organized this Public Lecture.
- In November 2006, Professor Pratap Bhanu Mehta, President and Chief of Centre for Policy Research, India delivered a Public Lecture, entitled "Asia's Role in the Current World Order". This Public Lecture was jointly organized by ISEAS and Singapore Indian Education Trust.
- In April 2007, Dato' Dr Michael O.K. Yeoh, CEO of Asian Strategy and Leadership Institute (ASLI) delivered a Public Lecture on "Recent Political and Economic Developments in Malaysia".

ISEAS also held a Roundtable discussion with the Minister for Foreign Affairs (Denmark), HE Dr Per Stig Møller on the topics of regional integration, political Islam, and political situation in Southeast Asia with a focus on Thailand and Myanmar/Burma in January 2007.

### Visitor Programmes

ISEAS hosts delegations from foreign universities, institutes, and governments. Groups from the U.S. State Department, Belgian Federal Public Service Foreign Affairs, German Federal Parliament, Indonesian Ministry of Foreign Affairs, Inter-American Development Bank, Asia Foundation, Japan International Cooperation Agency, China Institute of Contemporary International Relations, Australian Defense College, Mekong Institute, and Vietnamese Academy of Social Sciences, among others, have visited ISEAS this year.

aintaining the annual output of an average of over 50 new titles in recent years is increasingly becoming a challenge due to the lack of staff and greater demands on limited resources. Despite this, the Publications Unit has managed to maintain its high standards and implement new strategies to disseminate books on Southeast Asia throughout the world.

### **Another Prize for ISEAS Books**

For a second consecutive year, another ISEAS book has been awarded the title "Outstanding Academic Book 2006" by *Choice*, USA. The book is *Voices of Islam in Southeast Asia*, compiled and edited by Greg Fealy and Virginia Hooker. Not only has this book received an award, it is also on the Recommended Reading list for courses at Harvard, Australian National University, and Melbourne University.

## GoogleBooks

ISEAS' recent books are now on GoogleBooks to reach a wider audience. Google does not sell the books but helps the potential customer find it — by keyword, title, author. The reader can see the pages on screen in digital format. If the customer wants to buy the book, he simply clicks onto the hyperlink direct to ISEAS' website http://bookshop.seas.edu.sg, or to Amazon.com or Barnes & Noble.

#### ISBN-13

Beginning 1 January 2007, all current 10-digit ISBN (International Standard Book Number) were converted to the 13-digit ISBN. This is in response to the International ISBN Agency guideline. As the computer systems and inter-relational database of the Publications Unit is customized to handle all aspects of publishing, a consultant was engaged in order to enhance the systems to implement the new 13-digit ISBN. This upgrade is of special importance for bookshops and librarians who require the barcode and ISBN for orders, cataloguing, invoicing, stocks and inventory. The ISBN number is unique to each book: it identifies the book by publisher code, country, language and item number.

## **New Partnerships for ISEAS Publishing**

The promotion and marketing efforts of ISEAS
Publishing are attracting other well-known
scholarly publishers. As of 1 January 2007, ISEAS
Publishing became the exclusive Southeast
Asian distributor for the following eminent
presses:

- Nordic Institute of Asian Studies (Denmark)
- Monash Asia Institute (Australia); and
- East-West Center Washington for its Policy Studies Series on Southeast Asia.

These new partners are in addition to the existing partnership with KITLV, Europe's oldest research centre that publishes high-quality books on Indonesia.

# **Book Promotion Marketing and Distribution**

The Publications Unit continued to promote ISEAS books through

- ISEAS Books Catalogue 2006–07 distributed to 20,000 contacts in 100 countries
- 36 fliers printed and sent to 20,000 contacts worldwide
- 33 book displays at specialist academic conferences and meetings
- 28 e-mail alerts
- 45 book reviews in 36 journals and newspapers


# Reviews in the Press and Scholarly Journals


ISEAS books received exceptional coverage in the local press and international journals. More than 36 scholarly journals and newspapers published



Severino.







# **Library**

(Head: Miss Ch'ng Kim See)

Throughout the year, most of the Library's effort was spent on setting up the S. Rajaratnam permanent exhibition, which comprises a representative display of Mr Rajaratnam's books as well as photographs and descriptions of his life and achievements.

The report year saw increases in most areas of the Library's activities. Materials processed were 2.1 per cent more. The total number of registered users rose by 16.3 per cent; new users increased by 10.6 per cent compared with the previous year. The number of user visits saw an increase of 10 per cent over the previous year. Although books borrowed decreased by 15 per cent, in-house use of materials increased by 17.5 per cent and the number of visitors briefed and taken on Library tours increased by 0.8 per cent.

Ten thematic book exhibits were mounted and three subject bibliographies were compiled to support seminars held by ISEAS and visits of VIPs to the Institute. In addition, a bibliography on S. Rajaratnam and a catalogue of the S. Rajaratnam collection were compiled for publication.

The entries of records in the in-house indexing databases *SEABase* and *SEAText* increased by 1.8 per cent and 13 per cent respectively. There were marginal increases in *SEAPriv* and *SEABiog*.

The accumulated backlogs of unprocessed materials decreased by 2.7 per cent over the previous year.

This financial year, the Library's acquisitions budget was increased by 2 per cent to \$\$300,000 over the previous year with an additional \$50,000 to pay for the Horizon library software maintenance.

The ISEAS Library Advisory Committee (LAC) chaired by Dr Chin Kin Wah and comprising some ISEAS researchers and the Head, ISEAS Library was formed.

### **The Collection**

The Library's main collection at the end of the report year stood at 537,467 items. Processed print and microform materials totalled 414,072 items, i.e., 179,139 titles, an increase by 2.1 per cent (3,687 titles) over those of the previous year. This excluded the Southeast Asian Cultural Collection of audiovisual materials of 84,132 items and the backlog of 38,925 titles (or 39,263 items) of print and microform materials, which decreased by 2.7 per cent over the previous year. The breakdown of types of collection is as shown in Figures 3 and 4.

In February 2007, a freelance professional cataloguer Ms Aileen Ng was hired for a year, under Phase I of Accumulated Backlogs Clearance Project, to assist in the cataloguing of the microfiche backlog.

ISEAS Library Collection as at 31 March 2007




### Country and Language Coverage

Of the total collections, the Library had 120,084 processed titles on Southeast Asian countries and the region as a whole, an increase of 3.8 per cent over the previous year. This constituted 67 per cent of the Library's total processed collections as shown in Figure 5.

Vernacular languages of the region made up 49 per cent of the total library collection, inclusive of unprocessed titles, as shown in Figure 6.

# The S. Rajaratnam Book Collection and Exhibition

About 4,764 volumes, once the private collection of the late Mr S. Rajaratnam, former Deputy Prime Minister and first Foreign Minister of Singapore, were donated to the Library on 13 April 2006 by his nephews Datuk Dr S. Vijayaratnam and Mr S. Jothiratnam. About 1,000 selected titles were on display, as part of a permanent exhibit highlighting Rajaratnam's life and contributions to Singapore and the ASEAN region.




### Private Papers

The Library holds unique collections of private papers of prominent Singaporean and Malaysian personalities. In 2006, effort were made to expand the S. Rajaratnam Private Papers Collection, with the addition of 22 CDs of photographic images, glimpses of S. Rajaratnam, three audio CDs, four DVDs, 59 photographs, 29 video-cassettes, 35 slides, press clippings, articles, brochures, booklets, greeting cards, speeches, correspondences, newsletters, and books from various sources, including Rajaratnam's family, National Archives of Singapore, and Singapore Press Holdings.

Another nine negatives, four photographs and one postcard were also added to the Tan Cheng Lock Papers Collection by the Head of Library researching on the politician.

The National Museum of Singapore also deposited five DVDs of 278 images of items selected from the Library's David Marshall Papers Collection, which were used to mount the permanent exhibit at the Museum.

# Southeast Asian Cultural Collection (SEACC)

The SEACC, a multimedia documentation programme on the cultural aspects (habitat, culture, folklore, customs) of the Southeast Asian region comprised mainly colour slides, black and white

negatives and photographs, with the unique and valuable Dorothy Pelzer collection forming the core. SEACC now totalled 85,612 items, which included 173 black and white photographs of Sino-Vietnam Railway System by Ms Elisabeth Locard and 108 slides on Malaysia by Ms Linda Yip.

### **Acquisitions**

The acquisitions budget for FY2006/07 was reinstated to the level of FY2002/03 and the Library was able to buy more books than in FY2003/04 to FY2005/06. Donations of books from outside sources and depositions from the ASEAN Secretariat and the Asian Development Bank formed a large percentage of the increase. They constituted 30 per cent of the total materials acquired, adding a value of \$22,300.

In FY2006/07, the ISEAS Library purchased a total of 3,765 new titles, 1,115 titles or 42 per cent more than in the previous year. However, including research works, conference papers and ISEAS publications deposited with the Library, the total intake was 5,398 titles, 36 per cent more than in FY2005/06.

In order to augment its unique collections, the Library also requested for deposition of research work from visiting researchers as well as of conference papers from ISEAS researchers who attend non-ISEAS conferences. In 2006/07, a total of 87 research works and 44 sets of conference papers were acquired this way with an estimated total value of S\$13,172.30, representing an increase of 21 per cent.

The following were the major donors in FY2006/07:

- Madam Yeap Joo Kim 50 copies of Far from Rangoon, valued at \$1,495, and 50 copies of The Patriarch, valued at \$1,000.
- Ms Rosalia Sciortino, Director, Southeast Asia Regional Office, The Rockefeller Foundation — 52 titles valued at \$805.
- Ms Masya Spek, Consultant, Centre for International Forestry Research (CIFOR) — 61 volumes of Warta Ekonomi, valued at \$500.
- Dr Russell Heng, ISEAS Senior Researcher 2 volumes and loose copies of Saigon Newsreader, valued at \$50.
- Family of the late Lim Kim San, former
   Singapore Cabinet Minister (1916–2006) —
   131 titles valued at \$3,732.

## Depository Library

On 1 August 2006, ISEAS Library was appointed as the first depository library by the ASEAN Secretariat and received 25 titles in total. As a depository of the Asian Development Bank, the Library received 427 titles. From ISEAS itself, the Library received 54 new publications and 12 sets of conference papers.

### **Serials**

In 2006/07, the total Serials Collection stood at 1,751 titles, 9.18 per cent less than in the previous year due to a major exercise undertaken to clean up the database and streamline the collection.

A total of 142 new titles were added to the collection:

### Journals

There are altogether 642 current journals. Titles in Bahasa Indonesia and Malay comprise 67 per cent of the total for Southeast Asian languages.

Titles on Southeast Asia constitute the core collection. Those on Indonesia and Malaysia comprise 37 per cent of the total number on individual Southeast Asian countries.

### Newspapers

The Library subscribed to 34 newspaper titles and received two as gift. Two new titles *The Edge Malaysia* and *The Edge Singapore* were added to the collection.

## Serials Exchange Programme

The number of exchange partners (mainly libraries) stood at 128 with over 50 per cent from within the region. The Library received a total of 193 serial titles from its partners and sent out a total of 200 titles in exchange. Four new exchanges were established with Center for Khmer Studies Library, Cambodia; China Institute for International

Strategic Studies; University of Malaya Library, Malaysia; and National Museum of the Philippines.

### Serials in Microform

Efforts to reformat and acquire microfilms of vernacular and local newspapers were still ongoing as part of the Library's preservation and access policy.

# Computerized Databases SEALion (Southeast Asia Library Online)

The Library's online catalogue had more than 188,764 records of titles. The total search hit rate of *SEALion* was 167,709, an increase of 12.6 per cent over the previous year.

# SEABase (Southeast Asia Indexing Database)

SEABase, providing online access to important research work in journals and books, comprised 39,743 records. The number of new records totalled 692 entries. Of the 135 journals indexed, 112 titles were from Southeast Asia and 47 from the rest of the world.

# SEAText (Southeast Asia Full-text Database)

The SEAText database had 59,716 records of full-text articles. The number of entries this year was 2,177, an increase of 13 per cent compared with last year.

# SEABiog (Southeast Asia Biography Database)

The total number of records in the biography database was 2,572. Full text biographical articles (224 items) selected from websites, newspapers and other sources were scanned/input into SEAText.

## SEAPriv (Southeast Asia Private Papers Database)

SEAPriv database contained two full and three partial indexes of the following private papers: David Marshall; Tan Cheng Lock; Alex Josey; Gerald De Cruz; and S.Q. Wong. The other five collections of private papers — H.S. Lee, Loke Wan Tho, K.S. Sandhu, S. Rajaratnam and Tun Dr Ismail — are yet to be indexed.

### External Databases

The ISEAS Library continued its participation in the 69-member Singapore Integrated Library Automation Service (SILAS) database union catalogue programme since 1988. It contributed more than 50 per cent of original cataloguing records of its unique Southeast Asian materials. The Library subscribed to three outside databases, viz., Factiva Online, EIU Online, BAS Online and SMC (Singapore Malaysia Collection) Online, all of which were helpful to searches done by researchers and the Library.

### Circulation

### Users

Out of a total of 784, the library registered 417 new users with access period varying from one day to one year. The number of new users represented an increase of 10.6 per cent compared with the

previous year. On a total registered users basis, the increase amounts to 16.3 per cent. During the report period the number of user visits totalled 3,836, which was 10 per cent more than last year.

The categories of users are shown in the pie chart shown in Figure 7.

### Loans and In-house Use

There were 4,855 titles of materials borrowed out, and 86 titles of inter-library loans were issued to 13 local organizations. Only researchers with more than three months' affiliation at ISEAS, S. Rajaratnam School of International Studies, Lee Kuan Yew School of Public Policy, Institute of

Policy Studies, Asia-Europe Foundation and NUS were eligible to borrow materials.

### Reference and Information Services

A total of 488 enquiries were answered. This was an increase of 24.5 per cent in overall enquiry types compared with the previous year. The enquiries were received through walk-ins, telephone calls, e-mails, mails, and faxes.

### Thematic Book Displays

The ISEAS Library puts up thematic book displays regularly, mostly to coincide with the themes of ISEAS seminars. ### ISEAS Library Website

ISEAS Library's website are updated regularly to keep up with current information especially with its news, library services and the Southeast Asian links. Since the Library website was launched in 2003, the total visits numbered 99,165.

### **Publications**

The Library compiled *S. Rajaratnam*: A
Bibliography and *The S. Rajaratnam Catalogue in ISEAS Library* to coincide with the donation of
books from the private library of Mr S. Rajaratnam
and the setting up of permanent exhibition in
the Library in his honour. Both were scheduled
for publication in mid-2007. Three in-house
subject bibliographies were compiled: *Asean-China Bibliography; Subhas Chandra Bose and The Indian National Army;* and *Gender Issues in Southeast Asia.* 

# Training, Demonstrations, and Briefings

A total of 377 library tours and briefings were conducted. A group of about 40 librarians from the Special Libraries Common User Services Council under the auspices of the National Library of Malaysia visited ISEAS Library on a study tour on 22 August 2006.

Forty-eight National Library Board (NLB) professional and para-professional staff came for a tour of ISEAS Library on 23 November 2006 led by Dr N. Varaprasad, Chief Executive joined by Ms Ngian Lek Choh, Deputy Chief Executive, NLB. Both returned for a thorough briefing on 7 March 2007.

### **Training**

ISEAS Library provided a two-week in-house training to Ms Daraneth Oum, Librarian at the Centre of Khmer Studies, Cambodia as part of its regional cooperative networking in ASEAN countries.

### **External Links and Networks**

ISEAS Library continued to maintain its regional and international links and networks through book exchange programmes, visits of professionals and researchers, field trips and conference participation by Library professional staff. The Library was also active in networking through participation in

national and international cooperative projects, as follows: Inter-Agency Committee on the Chinese Overseas Databank and Research Collection (COCODR or HuayiNet Committee), Singapore; Digitization of Southeast Asian Materials Consortium, Singapore; Singapore National

Database (SILAS), Singapore; Council of Academic and Research Chief Librarians, Singapore; Institutes of Higher Learning Online Database Consortium, Singapore; and CORMOSEA (Committee on Research Materials on Southeast Asia), USA.

## **Administration**

(Head: Mrs Y.L. Lee)

he Singapore Government's annual grant, through the Ministry of Education and Ministry of Finance, is the major source of ISEAS funding. For FY2006/07, ISEAS received an operating grant of \$10,663,473. There was no development grant for the year as approval has not been received from MOE.

- higher than the grant of \$10,320,939 received in FY2005/06. This increase was mainly due to the payment of an additional 0.55 months of bonus to staff and revised higher rental of premises but offset by the headcount tax of \$10,000 imposed by MOE. The operating grant covered the cost of the physical infrastructure (building rental and maintenance), purchase and maintenance of equipment, library acquisitions and maintenance, staff salaries and some research and publication activities.
- In addition to the annual government grant, ISEAS also raised a sum of \$2,035,430 from other sources in FY2006/07. These were

donations, grants and contributions from external sources (international agencies, foundations, co-partners of research projects and conferences) and domestic private benefactors, as well as income from training programmes, public lectures and research consultancies. These monies helped to fund fellowships and scholarships, research projects, conferences and seminars, and some staff salaries.

The finance section was responsible for the accounting records kept to audit requirement and it also handled receipt of income and expenditures for the different units of ISEAS (namely, Administration, Research, Library, Publications, Computer and Public Affairs).

Appendix VI lists the donations, grants, contributions and fees received. The Institute wishes to express its appreciation to all donors and contributors for their generosity and support of its various intellectual activities.

# **Computer Unit**

(Head: Mr Nagarajan Natarajan)

he Computer Unit serves the Institute through implementing new technologies, maintaining IT infrastructure, providing technical services and support.

- The Computer Unit maintains the Institute's network infrastructure, which contains high-speed Gigabit Ethernet (GE) on the backbone and fast Ethernet connection to the desktops. The WAN Connection includes linking to NUSNET (NUS Network) for the Internet access and a leased line connection to BIG (Broadband Infrastructure for Government) for accessing Government services.
- The Unit maintains more than 15 servers running on different operating systems, supports more than 150 workstations and does regular backup of various ISEAS' systems, creates desktop image of workstations for easy recovery and coordinates with the vendor for regular off-site storage of backup tapes — to minimize down time and to provide efficient support.
- The Unit maintains various databases and applications efficiently with minimum downtime and provides helpdesk and technical support services to the Administration, Library, Publications Unit, and Research staff, visiting researchers, and trainees.
- As IT security is important the unit installed necessary firewalls and filters to block viruses and malwares and also actively promotes

- security awareness among the staff. It also maintains the computerized smart card security system and sets up for staff's access in ISEAS buildings.
- The Computer Unit develops various IT
   policies; and, with the support of the ISEAS
   management, implements them and educates
   users.
- The Computer Unit manages the ISEAS IT budget and new development projects.

In FY2006/07, the Computer Unit carried out the following:

- Implemented a new spam filter solution to block the increasing number of spam and virus e-mail messages.
- Redesigned the ISEAS's e-greeting card.
- Upgraded Office Applications of core researchers and staff.
- Posted more than 100 articles in the ISEAS
   Viewpoints section as part of its regular
   updating of the ISEAS website.
- Established the ISEAS podcast service.

### Current new projects include:

- Enhancing the online seminar registration module and mass mailing of seminar notices.
- Evaluating and implementing a web security solution to block trojans and spywares coming through the web.

- Continuing with the upgrading of firewall and implementing an intrusion prevention system and VPN solution for secure access.
- Continuing with the upgrading of workstations of researchers and staff.

Future plans include developing a portal that offers more e-services, upgrading the mail infrastructure, and implementing wireless solution for ISEAS.
